

ADULT HALLOWEEN COSTUME CONTEST

OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Campaign is open only to those who enter and who fit the appropriate categories as of the date of entry. Contestants must announce their desire to participate in the contest and allow a panel of judges to view their costumes. Contestants will be disqualified for inappropriate displays. The Campaign is only open to legal residents of the United States, and is void where prohibited by law. Employees of Blue Harbor Resort, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign.
