

SPOOKY SHEBOYGAN EXPERIENCE OFFICIAL CONTEST RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Campaign is open only to those who submit *Spooky Sheboygan Experience* contest entry via website form or in person at River Fest and who are over the age of twenty-one (21) as of the date of entry. The Campaign is only open to legal residents of the United States, and is void where prohibited by law.
